
2. For registration, a form is attached with and same could be downloaded from TSU website. Firms need to fill the form and provide the following documents in support:-

- h) Source of procurement of raw materials.
- j) Any other details firm wants to share.

3. Firms are required to submit the vendor registration form and above listed support documents by 22 Feb'2014.
